## 17/P/24 Applications

a. 23/00749/HSE | Proposed Part Two Storey Rear Extension, Part First Floor Side Extension Above the Existing Garage, Side Extension to the Existing Garage and New Front Porch | 16 Avon Road Oakley Hampshire RG23 7DJ. Revised plans

The Parish Council acknowledge that the stepped design to the garage brings it further away from the boundary lines shown on the plans but continue to object due to privacy and overlooking issues for neighbours as the mature trees shown on the plans no longer exist.

b. 24/00838/HSE | Demolition of existing garage and conservatory and erection of a single storey side and rear extension. Change of external appearance to include render. | 7 Lyde Close Oakley Hampshire RG23

c. 24/00858/FUL| Erection of 1 no. 3 bed dwelling with creation of new driveway, car parking and landscaping and stopping up of existing driveway | Land To The Rear Of 4 Fox Lane Oakley Basingstoke Hampshire RG23 7BB

Cllr. Rowley proposed no objection and comments relating to 21/00419/FUL (previous application) still stand – to approve the application with an attached condition that the building remains single storey and any further applications to build a second storey will be rejected. Proper screening between the neighbouring properties needs to be secured. Fox Lane is a very busy road, so construction traffic should park onsite.
